#### **PRODUCT VARIATIONS**

This policy applies to all lines of business unless noted below.

Application of Claim Payment Policy is determined by benefits and contracts. Benefits may vary based on product line, group, or contract. Payment may vary based on individual contract.

This policy is compliant and aligned with all CMS regulations and claim payment requirements.

## **POLICY STATEMENT**

The intent of this Claim Payment Policy Bulletin is to explain our payment position on durable medical equipment (DME) rentals and to communicate the list of DME items that are rented on a continuous basis and not subject to a rent-to-purchase cap limit.

Most DME rentals are considered capped DME and are rented until the rental cost of the device meets or exceeds the purchase price. This allows JHP members to own the item once the rent-to-purchase maximum is met.

There are some DME rentals which are considered continuous DME rental and are rented on a continuous basis and are not subject to a rent-to- purchase maximum. The JHP member will never own these DME items.

#### **POLICY GUIDELINES**

Durable medical equipment (DME) items may be:

purchased without a rental period.

All DME rental items require prior authorization to establish medical necessity.

DME is a covered service according to the individual's eligibility and HPP benefit plan. DME may be eligible for reimbursement consideration when ordered by a participating physician, considered a medically necessary treatment, and provided by an eligible participating DME provider.
